BYLAW # 224-2021

Advanced Poll

BEING A BYLAW OF THE VILLAGE OF GLENWOOD, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF AN ADVANCED POLL. GIVING QUALIFIED VOTERS WHO ARE UNABLE TO VOTE ON THE REGULARLY SCHEDULED MUNICIPAL ELECTION AS DETERMINED BY THE PROVINCE OF ALBERTA. FOR ASSESSMENT IN THE MUNICIPALITY OF THE VILLAGE OF GLENWOOD. THE ADVANCE POLL WILL BE HELD AT THE VILLAGE OF GLENWOOD OFFICE FROM 8 AM TO 10 AM. THIS POLL WILL BE HELD FIVE (5) WORKING DAYS, HOLIDAYS EXCLUDED, BEFORE THE MUNICIPAL ELECTION.

WHEREAS, pursuant to Sec 147 of the *Municipal Government Act*, being Chapter M-26, R.S.A. 2021 and amendments thereto, provides that a municipality may establish 5 councillors to carry out the powers, duties and functions of a council member under the *Municipal Government Act* or any other enactment or bylaw;

AND WHEREAS, Sec 147 of the *Municipal Government Act*, Chapter M-26, R.S.A. 2021 and amendments thereto, outlines the Election of councillors;

By-Elections will be considered the same as a Municipal Election for the purpose of this By-Law.

NOW THEREFORE the Council of the Village of Glenwood, in the Province of Alberta, hereby enacts as follows:

1. TITLE AND DEFINITIONS:

- 1.1 **Title** – This bylaw may be cited as the “Advanced Poll”.
- 1.2 **Definitions** – In this bylaw unless the context otherwise requires:
 - (a) **Advanced Poll** – Is a normal single voting opportunity in advance of the Municipal Election Date set by the Province of Alberta for qualified voters unable to vote on Municipal election day.
 - (b) **Municipal Election** – a voting day date set by the Province of Alberta for the election of Glenwood councillors.
 - (c) **Council** – means 5 members of the public to become the Council of the Village of Glenwood.
 - (d) **Mail In – NO votes will be accepted by mail.**

2. RECINDING BYLAW:

(a) Bylaw 224-2008

3. DATE OF COMMENCEMENT:

(a) This bylaw shall come into effect upon third and final reading.

Read a FIRST time this 12th day of August, 2021.

Read a SECOND time this 12th day of August, 2021.

Read a THIRD time and finally passed this 12th day of August, 2021.
