## VILLAGE OF GLENWOOD BYLAW # 262-2022

### Road Closure Bylaw

A BYLAW OF THE VILLAGE OF GLENWOOD IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF CLOSING TO PUBLIC TRAVELS PORTION OF PUBLIC ROADWAY TO CREATE TITLE IN THE NAME OF THE MUNICIPALITY FOR SUBSEQUENT DISPOSAL OF THE LAND THROUGH CONCOLIDATION WITH AN ADJACENT PIECE OF LAND IN ACCORDANCE WITH SECTION 22 OF THE MUNICIPAL GOVERNMENT ACT, REVIXED STATUTES OF ALBERTA 200, CHAPTER M-26, AS AMENDED.

**WHEREAS**, the land as hereafter described, as and as illustrated in the attached Schedule "A" are no longer required for public travel; and

WHEREAS application has been made to Council to have the roadway closed; and

**WHEREAS**, the council of the Village of Glenwood deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads, or portion thereof, situated in the said municipality, and thereafter creating title to same and disposing of same through consolidation with an adjacent piece of land; and

WHEREAS, notice of the intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act; and

**WHEREAS** Council was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw.

**NOW THEREFORE BE IT RESOLVED** that the Council of the Village of Glenwood in the Province of Alberta does hereby close to public travel for the purpose of creating title to the following described roadway for consolidation with an adjacent piece of land, subject to rights of access granted by other legislation:


