Application for the placement of shipping containers

Development Officer Vizzutti read the development application of Heartland Microgreens, Marty Trim for the temporary placement of two shipping containers on the property located on Lot 2, Block 13, Plan 1222AY, Street address 4th Avenue N.W. in the Village of Glenwood, under Land Use Bylaw 192-2019.

Development Officer Vizzutti placed the following into the record:

- Development application;
- 2. List of uses for the shipping containers;
- 3. Map showing names and locations of adjacent landowners who were provided with written notice of the application;
- 4. Site drawing showing placement of shipping containers and drainage directions;
- 5. Photographs of the shipping containers
- 6. Copy of Section 6 of Land Use bylaw 192-2019 as it applies to shipping containers
- 7. Copy of Time Extension Agreement.

Mr. Trim explained the shipping containers will be used to store building materials on the site to be used for the construction of a house.

Mr. Paul Clark entered the meeting at 5:10pm.

Mr. Clarke informed the Municipal Planning Commission he has no concerns regarding the application and he does not have an objection to the application.

Resolution 2024.DA.002 2024.01.24.05 **Moved by** Chairman Peterson that Development Application 2024.DA.002 be approved with the following conditions:

- That any outstanding permit fees owing be paid in full before the commencement of the placement of two shipping containers:
- 2. That the placement of the two shipping containers as shown in the photographs shall be set back in accordance with the minimum setbacks required under Section 3.1 of the Land Use Bylaw, as those setbacks required for an accessory building and shall not encumber any underground services including but not limited to water, sewer, or electrical conduit, as described in the documents provided to the Village of Glenwood, in the residential development application submitted on September 20, 2023;
- 3. The applicant/developer must contact Alberta 1st Call (1-800-242-3477) to locate any utility lines prior to placement of the two shipping containers, if the underground services referred to in Condition 2 cannot be verified, by the owner;
- 4. The development must be implemented in conjunction with the existing landscaping grades of the neighbouring lots. All drainage must either be retained on the property or flow to street side. The developer is responsible for implementing a drainage plan to deal with the drainage issues that will or may arise from this development;
- 5. The two shipping containers must be placed on a flat surface to prevent any sagging, sinking or tipping;
- 6. The two shipping containers must be painted a neutral color and maintained in a neat and tide appearance, and

7. The two shipping containers must be removed from the property on or before August 24, 2025, unless a development permit to extend the date of removal or the two shipping containers has been approved prior to August 24, 2025.
