#### **COMMON VOTING PROCEDURES:**

On election day, you will receive a ballot listing the names of all eleven candidates. You will be asked to mark the ballot by placing an "X" in the designated area on the right-hand side of the ballot, opposite the names of the five (5) candidates you would like elected to be on Village Council. Glenwood has a five-member council, one of which becomes the mayor and another the deputy mayor, as decided by the five newly elected councillors at their organizational meeting which is held within two weeks after the election.

#### You are eligible to vote in this election if you are:

- A Canadian citizen
- 18+ years of age
- Resides in Alberta and the person's place of residence is located in the local jurisdiction on election day. (A residence is the place where the person lives and sleeps and where they intend to return following an absence.)

## Village of Glenwood Candidates Forum

The next Municipal Election will be held on Monday, October 18. In preparation for your opportunity to vote, you are invited to attend a Candidates Forum.

Who: All residents of the Village of Glenwood When: Thursday, October 7, 2021 at 7:00 PM

Where: Glenwood Community Center

**Why:** Get to know the candidates and ask them some questions about their intentions

and goals for the upcoming four years, should they be elected to Village Council.

**How:** We will be running this meeting as any other Village Council meeting with the

following COVID restrictions in place...everyone must wear a mask; all chairs will

be placed for approved social distancing; microphones and common touch surfaces will be cleaned after each speaker. If you are showing any symptoms of

COVID, please do not attend.

#### **Ground Rules**

- All of the viable candidates will be included.
- Candidates who choose not, or are not able to participate in the forum may not send a substitute, but may submit a brief statement, which will be read by the moderator.
- Candidates will be asked the same question and have the same time to answer. Each candidate will have two (2) minutes to respond. Time limits on responses will be strictly observed. A timekeeper will hold cards, visible to the speaker, indicating how much time remains. When the "stop" card is shown, the speaker must end their speech within ten (10) seconds.
- The moderator will have the responsibility for enforcing time limits.
- The moderator will also have the authority to interrupt the proceedings to enforce the ground rules and format agreed upon by all candidates.
- The moderator may restate the question but cannot ask a follow-up question.
- The person who serves as moderator will have no connection with the candidates or with issues that any of the candidates are strongly identified with.
- The candidates will not interrupt one another.
- Candidates should refrain from personal attacks or charges. Answers should remain focused on relevant policy topics.
- The candidates' closing statements should be significantly related to the matters discussed previously. Candidates will have ninety (90) seconds for closing statements.
- Candidates are invited to remain after the forum to meet with attendees outside of the forum hall.
- No candidate literature/paraphernalia will be displayed or distributed in the meeting room. This
  means that candidates and their supporters will be asked not to wear any campaign badges, tee
  shirts, etc. during the forum. After the forum, candidate literature may be placed on the tables
  provided outside the meeting room.

**DOG BYLAW**: There will be a new dog bylaw presented at the October Council Meeting. As discussed in several other editions of this newsletter, there has been a problem with strays and dog poop. Please visit <u>glenwood.ca</u> to read the new proposed bylaw.



One of the new services from the Alberta Government is an online Emergency Registration System. When you log into emergencyregistration.alberta.ca,

you can register yourself and your household member, even pets. This information is used only during an Emergency Event in our local area and is shared with the Evacuation Center when you check in, thus making the process much easier during a stressful time. If you need help or don't have access to the internet, call 310-4455 and operators can take your information and get you registered.

They are available 24/7.



#### VILLAGE ELECTION REFERENDUM QUESTION

Dear Residents,

A certain Internet service provider (ISP) has approached council in recent months to present an opportunity. The ISP believes it can obtain a federal grant that would fund the installation of fibre-optic service for the Village. This would mean fibre-optic internet service available to each lot in Glenwood.

Village council believes such a development to be beneficial as it would provide a more reliable Internet option than what is currently available here. This may be an important factor for those who work from home or who have a home business (or would like to).

However, to qualify for the grant, the Village would be required to contribute \$75,000 over 3 years (that's \$25,000 per year). There is no room for this expense in the budget without raising taxes specifically for this project.

As such, a referendum question will be included on the ballot in the upcoming municipal election asking whether you would support an additional fee included with your taxes in order to raise the required funds. This fee would average around \$150 per lot each year for 3 years.

This fee is subject to us receiving the grant.

Please come out and vote to make your position known!

#### Village of Glenwood Alberta

Amended By-law #219-2007 May 2008 Amended By-Law #219-2007 Jun 11, 2009

#### **Animal Control By-law**

pursuant to the Municipal Government Act Section M-26-1.

#### **Section I - Definitions**

- 1 Animal means livestock, bees, dogs, reptiles, or any other mammal.
- 2 Animal Control Officer- ACO A person appointed by Council.
- 3 Controlled Confinement means penned enclosed with barbed wire or electric fence for livestock, fenced with a non passable fence for dogs.
- 4 Dog Tag A license issued by the Village of Glenwood.

#### Section II Livestock allowed or not allowed in the Village of Glenwood.

- 1 Not Allowed Bees Poisonous Animals Pit Bull Dogs- Except temporarily as per Section III, clause 7.
- 2 Allowed Horses, Cattle as per Section Ill. Dogs male or female as per Section Ill.
- 3 Any other mammals not included above may or may not be allowed as decided by Council.

#### **Section III - Controls**

- 1 Any person possessing Livestock in the Not Allowed list above will be subject to Compliance Procedure One see below.
- 2 Three horses and or cattle, in any combination totalling three, are allowed per acre. Only pasture land is used in the per acre calculation, not residential land. More than three Livestock will be subject to Compliance Procedure Two.
- 3 Any person possessing a dog more than three months old, must obtain a license tag from the Village Office.
- Fees are Spayed female \$15 Non spayed female \$20 Male neutered \$15 Male non neutered \$20 Any person not tagging their dog is subject to Compliance Procedure Three.
- 4 Dogs are not allowed to run at large; they must be constrained to the owners property. If in the opinion of the ACO an observed tagged dog is at large occasionally, and not habitually, the ACO will phone the owner and request the dog be captured. If after more than three requests, and the dog is at large, the ACO will issue a written notice that further violations will result in a fine. Fines are first offence \$25, second offence \$50 third and further offences \$100. Unlicensed dogs will be immediately captured and taken to a containment area.
- 5 Confined Dogs Captured dogs will receive 'best effort' to locate their owner. Upon identifying the owner the dog will be released upon purchase of a license (if unlicensed) plus fees incurred for confinement at the rate of \$10 per day or portion thereof. If the owner is not located within ten days, the dog will be sent for adoption or euthanasia as per SPCA rules.
- 6 Short Term Dogs Persons tending dogs for periods of up to three weeks for friends or relatives do not require a dog tag, however all other bylaw conditions must be complied with.

7 Events - Animals brought into the Village for purposes of shows, trials or the like, are allowed upon obtaining written permission of the ACO. These animals must at all times be controlled by their handlers. Pit Bulls are allowed for a period of up to one week, or until the end of the event whichever comes first. Conditions are stated on the permission form.

8 Vicious Dogs - Vicious Dogs are not allowed. Pit Bull Dogs are termed Vicious and are not allowed except as stated in Section III, clause 7 above. Any dog which in the opinion of the ACO is vicious, will be referred to the RCMP for further resolution under the Dangerous Dog Act- Provincial Law.

9 Habitual Barking Dog. Any dog which barks or creates a disturbance continually, in the opinion of the ACO, is a habitually barking dog. Complaints may be submitted in writing to the ACO for investigation. Upon the ACO deeming a dog as habitually barking, a written notice will be issued by the ACO to the owner. If compliance is not obtained within a 10 day period, then a fine of \$25 first offence, \$50 second offence, and \$100 third and following offences each will be levied.

10 Dogs on Leash. Dogs being walked must be on a leash. Leashes may be corded or electronic. Dogs feces on property which is not the owners property, must be cleaned up immediately by the dog owner. Failure to do so will result in a fine of \$25 first offence, second offence \$50, \$100 third and further offences.

#### **Section IV Licensing**

The Village of Glenwood will keep a record in which the name and address of each owner, the dogs description, the tag number, complaints, offences, fines, are recorded.

#### Section V Compliance Procedures

Complaints must be submitted in writing to the Village ACO. All fines are issued by the RCMP upon notification by the ACO of non compliance.

1 Compliance Procedure One - Upon observation of the ACO or written complaint from a resident of Glenwood, of voting age, the alleged non compliance will be referred the ACO. If in the opinion of the ACO non compliance exists then livestock owner will be given 15 days written notice to remove the livestock. Upon a second later complaint or further non compliance, the ACO will issue a second written notice for removal limiting the time to 10 days. If the Livestock remain after two written notices, the ACO will proceed to have the Livestock impounded in conjunction with the RCMP. Costs will be invoiced and added to the owners Tax Role after 60 days if the invoice is not paid.

2 Compliance Procedure Two - Upon observation by the ACO, or upon written complaint from a resident of Glenwood of voting age, the owner of horses or cattle who does not remove or spread manure on June 15th will be given ten days written notice to comply. If after that period of time in the opinion of the ACO a fine of \$25 first offence, \$50 second offence, subsequence offences will result in the manure being removed and all cost invoiced to the property owner. Unpaid invoices will be added the Tax Role after 60 days.

3 Compliance Procedure Three - Upon observation by the ACO, or upon written complaint from a resident of Glenwood, of voting age, the owner not having a license tag will be given written notice to comply within 15 days. If this is not done then a second letter will be written giving 10 days notice. Further non compliance will result in a fine being issued in conjunction with the RCMP of \$25.) Further infractions are fined \$50 second offence, and \$100 for subsequent offences. Any portion of this by-law struck by a court leaves the remainder standing.




